And when one of them is informed of [the birth of] a female, his face becomes dark, and he suppresses grief, He hides himself from the people because of the ill of which he has been informed. Should

he keep it in humiliation or bury it in the ground? Unquestionably, evil is what they decide.¹

Meanwhile, some of them used to kill their daughters even buried them alive, to avoid facing the situation of anxiety and insult. This described in Quran also as:

And when the girl [who was] buried alive is asked, for what sin she was killed²

All around, couple of people have misunderstand that women fortifying and sexual introduction is an outside arrangement yet its single misinformed judgment. Women wherever all through the world have been going up against troubles and sex awkward nature since the beginnings of history. Famous writer Demosthenes says:

Woman in Roman Civilization:

In Rome, the status of women was worse than her sister in Greek. Roman law denied the lady of her social liberties; thus, her legitimate identity was not recognized by any means. It thought about lady as a reason for all ills and free her off all rights⁵

The Persian country was essentially a military country. Man is viewed as a mainstay of the battling parcel, i.e., they have much noteworthiness. In this way, they favored man to lady, since lady was made to serve others; other than guardians. Resultantly, lady, in Persian human advancement, additionally appear to have lost their rights⁶

Woman in Indian Civilization:

In Indian Civilization, women had the status of no more than a slave. Individuals lost them in betting; they didn't significantly consider a lady as person, to such an extent Hindu law disrespect lady and perceives her beneath awful air, passing, heck, toxic substance, snakes and fire, and so forth along these lines, they made the law that lady could do nothing her very own will. They thought about spouse as a delegate of God. On the off chance that her better half passed on before her, they used to consume her bursting at the seams with him..⁷

Woman in Chinese Civilization:

In the event that nobody got her there, he used to abandon her in a betrayed territory, or choked her to death or toss her in water, or covered her alive. Once in a while, he left her in the open fields with the goal that the cool ice could execute her of predators could eat her. Muslim traveler Ibne Batuta has referenced in his travelog that the Chinese individuals sold their little girls and did not think about it awful.⁸

The Chinese perceived women as trick and non-sense. She didn't have any capacity to determine any issue identified with her existence without the direction and help of a man. She was a hopeless animal and was abused. Neither did she have any light nor might she be able to request any. When she got hitched, they called her 'Fu', i.e., "obedient"⁹

Woman's Role and Traditional Misconceptions:

Islamic development, ideal from its begin as *Din e Hanif* (Barahamic Religion), has given ladies their due jobs to perform with the end goal to develop an ordinary society which is need of great importance and it is additionally a subject of hot discussion in both East and West. Particularly the general population out of Islamic space question their sexual orientation and in addition physical jobs with various ladies to feel themselves hampered or to be reliant on others particularly the guys of the general public basically trading off on their independence.

Thus as a matter of first importance recognition about the life of women in Muslim society is the autocracy of their male relatives who, thusly, constrain them to wed without wanting to or to wear cover. Curiously; in an Islamic culture every one of these jobs require no legitimization. They are allowed to fill in as providers keeping in view their household settings and along these lines no social marks of shame can be related with their embraced jobs and which can be considered to dominate their sex in general.

As a rule; every one of the marks of shame which the pariahs connect with the ladies in a Muslim society are really connected with different social orders as well. Henceforth; in various Muslim social orders previously, ladies kept on exceeding expectations in relatively every field of enthusiasm, running from gems, engineering and writing to the fields of fighting. In the times of solidified Muslim control, it was the obligation of Khalifa to give training to women and give esteemed employments to ladies of gauge and skill. That is the reason Muslim society the two regards and urges the ladies to be profoundly instructed and capacitated with the end goal to meet the cutting edge prerequisites. Muslim social orders are making vital plans for women instruction both at scholastic and expert levels. Here is a basic investigation of various societal jobs and obligations in the light of Islamic lessons.

Equality in Islam:

Being the delicate part of the society, to redress the affliction of the suppressed women and to uplift the passion, participation and spirit in the society, Islam has equalized this gender in every sphere of life as is described in the following points:

- * Equality in worship (prayer, fasting, hajj and umrah etc.)
- * Equality before Islamic Law
- * Equality in civil matters
- * Equality in responsibilities and empowerment
- * Equality in Liabilities and Penalties
- * Equality in Final Reward and Punishment

In the depiction of devout characteristics of the devotees, the Holy Quran makes reference to furthermore, talks about women parallel with men. This value is a huge piece of the exertion set up by the Holy Quran for women's legitimate position in the public arena. The Quran shows a reasonable and straightforward

idea that in the affiliation with Almighty Allah, in the Islamic commitments, and in the viable lead, both sexes ought to be viewed as similarly situated.

“Verily, the Muslims (those who submit to Allah in Islam) men and women, the believers men and women (who believe in Islamic Monotheism), the men and the women who are obedient (to Allah), the men and women who are truthful (in their speech and deeds), the men and the women who are patient (in performing all the duties which Allah has ordered and in abstaining from all that Allah has forbidden), the men and the women who are humble (before their Lord Allah), the men and the women who give Sadaqat (i.e. Zakat, and alms, etc.), the men and the women who observe Saum (fast) (the obligatory fasting during the month of Ramadan, and the optional Nawafil fasting), the men and the women who guard their chastity (from illegal sexual acts) and the men and the women who remember Allah much with their hearts and tongues (while sitting, standing, lying, etc. for more than 300 times extra over the remembrance of Allah during the five compulsory congregational prayers) or praying extra additional Nawafil prayers of night in the last part of night, etc.) Allah has prepared for them forgiveness and a great reward (i.e. Paradise).”¹⁰

In the above verse, specific notice has been made of the adequacy of the deeds of ladies to conciliate the hearts of ladies towards Islam and to upstanding them. The Holy Quran clarifies that the touchstone of acknowledgment of deeds furthermore, their prizes in seeing Almighty Allah is the honorableness of the deeds furthermore, the soul of compliance to Almighty Allah. In this association, there is no separation among man and lady. The two sexes are similarly obliged to revere Almighty Allah, and both will confront a similar requital. Allah has favored the two guys and females with the sufficient ability to obey and venerate.

“Whoever works righteousness, whether male or female, while he (or she) is a true believer (of Islamic Monotheism) verily, to him We will give a good life (in this world with respect, contentment and lawful provision), and We shall pay them certainly a reward in proportion to the best of what they used to do (i.e. Paradise in the Hereafter).”¹¹

Spiritual Empowerment:

In Islam, women have equally been given the opportunities of worship, good or bad actions, and good and tragic way of life in this world and the hereafter as is described in the following verses of Holy Quran:

“O mankind! reverence your Guardian-Lord, who created you from a single person, created, of like nature, His mate, and from them twain scattered (like seeds) countless men and women;- reverence Allah, through whom ye demand your mutual (rights), and (reverence) the wombs (That bore you): for Allah ever watches over you.”¹²

Economic Rights:

Islam has also empowered woman about fifteen centuries ago that now can only be thought a dream now. There are a lot of liabilities may be possessed by a woman; she can get, sell, buy, gift and have parts in properties, business and welfare works as the Holy Prophet SAW said:

((قد اجرنا من اجرته يا ام هاني))¹⁴

Dr. Zakir Naik say in elaborating this statement:

“Islam has given the right to woman to sell her property about fifteen centuries ago which later on adopted by British parliament in 1870.”¹⁵

Islam has presented a Muslim lady such budgetary and sparing rights, which no other society, culture or religion presented to her. Islam has given equivalent rights to Muslim male and female to have, contract and play out a wide range of contracts. She has sole right of her ownership and men in any connection or in any frame can't meddle her rights. Accordingly, a Muslim lady can play out her monetary and financial issues with no block and limitation. She can discard her assets with full circumspection. She has the privilege to move, buy, rent and business, hypothesis and other money related contracts and in addition gift, philanthropy, commitment and devotion which are performed to look for the desire of Almighty Allah.

Women have been empowered in further to:

- * Have work according to Shariah
- * Own her property
- * buy and sell her belongings
- * Dispose of her belongings
- * Have inheritance rights

Women were denied any privilege previously. Prominently, their privilege of possession was recognized once in a while. Indeed, they were conceptualized as an article of ownership which could be transmitted by legacy like different belongings. On the other hand, Islam thinks about that the two people are respectable and merit the privilege of proprietorship. Islam acknowledges a family as the basic unit of society and urges to build up adoration, warmth, and care of the family unit.

“And wish not for the things in which Allah has made some of you to excel others. For men there is reward for what they have earned, (and likewise) for women there is reward for what they have earned, and ask Allah of His Bounty. Surely, Allah is Ever All-Knower of everything.”¹⁶

Social Empowerment:

A woman is the integral part of worldly life. Since the creation of the world she has been part and parcel of the society. Islam titles woman as:

- * Mother
- * Daughter
- * Wife

* Sister

As mother, Islam titles it as very next to Allah's worship. Allah's worship is obligator on each Muslim; men and women as stated in the Holy Quran:

*"And your Lord has decreed that you worship none but Him. And that you be dutiful to your parents. If one of them or both of them attain old age in your life, say not to them a word of disrespect, nor shout at them but address them in terms of honour."*¹⁷

As Daughter:

Islam has given reverence to the daughter and abolished all the previous deities to burn or bury the them in their childhood. The Quran well states their status in the following verse that denote their social status of that time:

*"And when the news of (the birth of) a female (child) is brought to any of them, his face becomes dark, and he is filled with inward grief! He hides himself from the people because of the evil of that whereof he has been informed. Shall he keep her with dishonour or bury her in the earth? Certainly, evil is their decision."*²⁰

Islam does not let any person to burn or bury his daughter but he will accountable on the Day of Judgment. It is clearly mentioned in the following verse:

*And when the female (infant) buried alive (as the pagan Arabs used to do) shall be questioned.*²¹

As Sister:

Islam gives respect and reverence to women in every case; mother, wife, daughter and sister as well. As a sister, Islam gives much respect to her:

The believers, men and women, are Auliya' (helpers, supporters, friends, protectors) of one another,²⁴

As believing person, men and women are mutual brothers and sisters and the enjoin virtues and prohibit them from evils. So, it is mandatory for each and every one to be respectful for his or her brother and sister.

As Wife:

A woman got abuse in the Arab society. Spouses had the full ideal to pawn their spouses and kids, beat them barbarously and pull their hair with no confinement. Ladies did not have any parental rights over their kids moreover. Spouses were kept inside the family just to bring forth youngsters and to deliver male posterity. Obviously, in these conditions, it was basic to feature the requirement for kind treatment with spouses. Thus, the Holy Qur'an educates adherents to embrace a frame of mind of graciousness with spouses as:

كَرِهْتُمُوهُنَّ فَعَسَى أَنْ تَكْرَهُوا شَيْئًا وَيَجْعَلَ اللَّهُ فِيهِ خَيْرًا كَثِيرًا﴾

"O you who believe! You are forbidden to inherit women against their will, and you should not treat them with harshness, that you may take away part of the Mahr you have given them, unless they commit open illegal sexual intercourse. And live with them honourably. If you dislike them, it may be that you dislike a thing and Allah brings through it a great deal of good."²⁵

Aside from the abuse and concealment of rights, there was another despicable custom in Arabia. A strange practice as to ladies in pre Islamic Arabia was that if a woman kicked the bucket, his child from a past marriage was qualified for wed his significant other on the off chance that he needed so. The Holy Quran censured and prohibited this despicable practice generally insistently:

﴿وَلَا تَنْكِحُوا مَا نَكَحَ آبَاؤُكُمْ مِنَ النِّسَاءِ إِلَّا مَا قَدْ سَلَفَ إِنَّهُ كَانَ فَاحِشَةً وَمَقْتًا وَسَاءَ سَبِيلًا﴾²⁶

“And marry not women whom your fathers married, except what has already passed; indeed it was shameful and most hateful, and an evil way.”

Apart from this, a woman as a wife has also been entertained with the following paramount certain rights:

- * To choose a life partner
- * To have dowry and ownership
- * Fostering rights
- * Right of Khula
- * To care the members of the family
- * Equality in human values

Social Rights:

Being the paramount member of the society and family, a woman has been given equal right as for men in Islam in politically and in gaining social security benefits. In previous, it was not a tradition that if a woman is killed and shot to death, the killer was not sentenced to death in Jewism, Christianity and in any other religion. It is Islam that gives this very equal right as is mentioned in the following verse:

﴿يَا أَيُّهَا الَّذِينَ آمَنُوا كُتِبَ عَلَيْكُمُ الْقِصَاصُ فِي الْقَتْلِ: الْحُرُّ بِالْحُرِّ وَالْعَبْدُ بِالْعَبْدِ
وَالْأُنْثَىٰ بِالْأُنْثَىٰ ۖ فَمَنْ عُفِيَ لَهُ مِنْ أَخِيهِ شَيْءٌ فَاتِّبَاعٌ بِالْمَعْرُوفِ وَأَدَاءٌ إِلَيْهِ بِإِحْسَانٍ ۗ
ذَلِكَ تَخْفِيفٌ مِّن رَّبِّكُمْ وَرَحْمَةٌ ۚ فَمَنِ اعْتَدَىٰ بَعْدَ ذَلِكَ فَلَهُ عَذَابٌ أَلِيمٌ﴾²⁷

“O you who believe! Al-Qisas (the Law of Equality in punishment) is prescribed for you in case of murder: the free for the free, the slave for the slave, and the female for the female. But if the killer is forgiven by the brother (or the relatives, etc.) of the killed against blood money, then adhering to it with fairness and payment of the blood money, to the heir should be made in fairness. This is an alleviation and a mercy from your Lord. So after this whoever transgresses the limits (i.e. kills the killer after taking the blood money), he shall have a painful torment.”

The Holy Quran endorses a substantial discipline for every one of the individuals who denounce the virtuous ladies of infidelity without giving considerable proof in help of their allegation. Normally, if individuals were permitted to blame virtuous ladies without distinct confirmation, abuse of the law would turn out to

be extremely plentiful. Numerous men could make such allegations of stifling or startling the ladies. Thus, every lady would feel compromised with false charges. In this way, to secure the respect of ladies, the Holy Quran diagrams a discipline for the false allegation that is relatively equivalent to that of infidelity.

﴿وَالَّذِينَ يَرْمُونَ الْمُحْصَنَاتِ ثُمَّ لَمْ يَأْتُوا بِأَرْبَعَةِ شُهَدَاءَ فَاجْلِدُوهُمْ ثَمَانِينَ جَلْدَةً وَلَا تَقْبَلُوا لَهُمْ شَهَادَةً أَبَدًا وَأُولَٰئِكَ هُمُ الْفَاسِقُونَ﴾²⁸

“And those who accuse chaste women, and produce not four witnesses, flog them with eighty stripes, and reject their testimony forever, they indeed are the Fasiquun (liars, rebellious, disobedient to Allah).”

﴿إِنَّ الَّذِينَ يَرْمُونَ الْمُحْصَنَاتِ الْغَافِلَاتِ الْمُؤْمِنَاتِ لُعِنُوا فِي الدُّنْيَا وَالْآخِرَةِ وَلَهُمْ عَذَابٌ عَظِيمٌ﴾²⁹

“Verily, those who accuse chaste women, who never even think of anything touching their chastity and are good believers, are cursed in this life and in the Hereafter, and for them will be a great torment,”

History stands observer that ladies were in a genuine condition of instability. In this way, Holy Quran, completely, guaranteed their security and annulled all hazardous customs against ladies. The Holy Quran extremely astutely tended to those undertakings of lady's life which were utilized against them for example, the introduction of a female tyke, marriage, separate, the privilege of legacy and social uncertainty. On the other hand, exceptionally productive and handy measures were acquainted and authorized with assurance the inside and out security of ladies in the society.

Political Rights:

History witnesses that women have also played a pivotal role in politics, policy making and formulation of government and various rulers. One of the best examples regarding her role in politics can be rendered here as Hazrat Ayesha R.A who played her vital role in Battle of Mustalaq, Conquest of Makkah, Battle of Camel. Hazrat Umme Habiba R.A. and Hazrat Umme Salma are also the prominent figures who performed their key role in and against various rulers.

There are certain social rights given to women as social member:

- * Right to advise the guardian
- * Right to advise the ruler
- * Right to challenge the unjust ruler
- * Right of shelter

- * Right to monitor current events
- * Judicial rights
- * To pledge allegiance
- * To participate in Jihad

Conclusion:

This article talked about the situation of ladies in different settings and their procedures for survival and change, with specific spotlight on originations in regards to innovation and ladies rights, secularism with woman's rights and Islamic way to deal with manage it in a practical methodology. The religious writings of Islam (the Quran and the Sunnah) and Islamic (Shari'ah) law, and their suggestions for ladies demonstrate the extraordinary arrangement of rights gave to them under Islamic umbrella. There had been unique elucidations of these writings particularly in setting of ladies job. Shari'ah laws are executed extraordinarily through the talk of individual status laws that are based on Islamic standards to grant different social jobs that a lady can seek after in social life.

Islam itself contains a very much characterized political logic and arrangement of administration. The best procedure for impelling women's rights in Islamic states is to change existing Islamic law. Building up broadened women rights in Islamic law offers the best likelihood for proceeding with challenges to these rights, as these progressions have a veritable genuine start and demand to ordinary social and social characteristics s. As needs be, Islamic culture is bound to acknowledge these extended rights as real. Legal requirement is as essential as formal legitimate change, and establishing extended ladies' rights in Islamic law gives authenticity that will help the legal executive's acknowledgment and implementation of these rights. Along these lines, Muslim women can be a bit of present day world getting a charge out of all political and social rights with full help, with a satisfaction that these rights are not won through acquiring western characteristics, rather Islam has given them all of these rights to walk around the present-day world with fulfillment.
